

TOWN OF WILKESBORO

APPLICATION FOR PEDDLER PERMIT

DEFINITION: § 111.01 PEDDLERS OF BOOKS, MAGAZINES AND THE LIKE.

It shall be unlawful for any person engaged in the business, trade, or profession of peddler, book agent, magazine agent, or salesperson traveling on foot or by vehicle or other conveyance of any kind and going from house to house or from person to person and soliciting patronage in his or her respective line of business, to peddle his or her wares, publications or other merchandise of whatsoever kind or description upon the streets of the town or in any public place within the corporate limits of the town without first procuring a permit from the Board of Commissioners to engage in the business. *(Prior Code, § 10-11) Penalty, see § 10.99*

 - ❖ If the Applicant is an employer or principal, a separate application shall be submitted for each person who will be peddling or soliciting, a separate permit will be issued for each.
 - ❖ The Town Council or his/her designee will approve or reject the application typically within (45) days from the date of the application

The Application may be rejected for the following reasons:

1. The application is incomplete.
2. The application fee has not been paid.
3. The application contains false or misleading statements.
4. The applicant has committed prior ordinance violations pertaining to solicitors and peddlers.
5. The applicant has been convicted of a misdemeanor involving larceny, fraud, forgery, sale of counterfeit goods, and/or breaking and entering.
6. The applicant has been convicted of felony; and
7. Any other reasonable evidence that the applicant would pose a substantial threat to the public health, safety, morals, and general welfare.
